IN SUPPORT OF STRENGTHENING OSCE ACTION AGAINST THE ILLICIT PROLIFERATION OF SALW AND SCA:

SOUTH-EASTERN EUROPE

INTRODUCTION

The participating States recognize the importance of OSCE practical assistance measures aimed at combating illicit trafficking in all its aspects with regard to small arms and light weapons (SALW) and stockpiles of conventional ammunition (SCA) and their contribution to the reduction and prevention of the excessive and destabilizing accumulation and uncontrolled spread thereof.

OSCE ASSISTANCE MECHANISM IN SALW/SCA

The OSCE has a proven, transparent and well-functioning mechanism for providing assistance to States as established by the OSCE documents on SALW and SCA. Both OSCE participating States and Partners for Co-operation can submit official requests for OSCE assistance.

Through a systematic approach the assistance mechanism verifies and validates concerns on SALW and SCA which were raised by the participating States. It confirms the requirements for external assistance and its feasibility. Moreover, the mechanism supports determining the scope of the assistance needed and provides recommendations for the project development and further implementation.

PORTFOLIO OVERVIEW

The OSCE practical assistance projects are managed, co-ordinated, implemented and evaluated by the FSC Support Section, and conducted on the ground mostly through the OSCE field operations.

The scope of assistance through project work in South-eastern Europe among others includes:

- improving legislation and regulations to effectively control SALW/SCA;
- improving SALW/SCA storage infrastructure, ammunition surveillance & record keeping;
- enhancing management of SALW armouries & SCA storage sites;
- raising awareness on SALW control;
- enhancing capabilities in countering illicit trafficking of weapons, ammunition and explosives.

PORTFOLIO FINANCIAL OUTLOOK

As of July 2020, the overall value of the project portfolio in the South-eastern Europe is EUR 15.9 millions.

Close to EUR 6 millions have been committed to support SALW/SCA projects in South-eastern Europe. However, almost EUR 10 millions are still required to assist the requesting States in addressing a wide array of security and safety risks through assistance projects.

OSCE SALW/SCA Repository Programme is a centralised funding mechanism devoted to coordination and management of financial resources allocated to the relevant projects throughout OSCE region.

The strengths of this funding mechanism are its transparent management of resources, swiftness of allocation pursuant to the instructions of the donor, and ability to channel funding through the OSCE executive structure all over the OSCE region.

All types of pledges are supported. Earmarked funding can be pledged to the specific programme/project, or against the request for assistance of a participating State, that is yet to be developed into specific project.

Also, generic non-earmarked funding can be made thematically (e.g. specific programmatic field within the SALW/SCA) and/or geographically (by country/region)

Procedural safeguards envisage that the use of all pledges is agreed with the donor based on their explicit prior written consent.

Every donor may define preferred procedures on the further use of the pledge, with details on reporting, disbursement, etc.
